SPECIFICATION

1. The candidate's designation is not valid because she fails to meet the qualifications for the office set forth in the New York State Constitution, Article IV, Section 2, with respect to residency. Election Law §6-122.

2. Respondent the candidate has admitted in a television interview that for extended periods during the five-year period preceding the election she did not have a permanent place of abode in New York State.

2. Upon information and belief, for a long period of time during the five-year period the candidate did not have a New York driver's license; rather she had driver's licenses in other states.

3. Upon information and belief, for a significant length of time during the five-year period the candidate maintained her mailing address in the State of Vermont and only filed a NCOA change to New York quite some time after November 2009.

4. Upon information and belief, the candidate maintained other *indicia* of residence in Vermont during the five-year period and at times when she had no place of abode in New York.

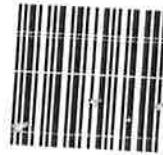
5. The foregoing examples, and other information that has come to the attention of your objector, constitute evidence extraneous to the Board of Elections' records and are therefore beyond the Board's jurisdiction.

6. Accordingly, objector will proceed in court to challenge the candidate's eligibility for the designation due to her lack of continuous residency in New York for the five years proceeding the coming General Election.
